## Proposed Transfer GPA requirements via Committee on Scholastic Standards and Petitions (FYI)

Note: At present the Readmit and Change of Campus requirement is 2.25. The requested change does not address these two categories of admission.

#### ORGINAL PROGRAM CURRICULUM:

**Required GPA for Transfer Students** 

Transfer students must have a minimum average GPA of 2.25 to enroll in the Department of Retailing.

#### CHANGES TO PROGRAM CURRICULUM:

**Required GPA for Transfer Students** 

Transfer students must have a minimum average GPA of 2.50 to enroll in the Department of Retailing.

#### Justification:

The Retailing Department has voted to increase our minimum GPA from 2.25 to 2.5.

We believe that this move will help us to improve the quality in our courses which our recruiters are demanding in new management trainees (e.g., Kohl's, Belk, Target, etc.).

In addition, as we move to work with firms specializing in JDA, Salesforce, and Category Management (i.e., CVS, Walgreens, Amazon) we need to be generating a high quality student who comprehends these complex software packages.

In addition, we believe that an increase in our GPA will help us increase our national and regional reputation and ranking.

*Kelly moved to approve the minutes of the 9/2/19 meeting. Miller seconded. Motion carried. Wagner presented overview of application cycle for spring and fall 2020. Report attached.* 

#### For Review:

Smith called for review of proposed transfer GPA requirements for Retailing, raising min transfer GPA requirement from 2.25 to 2.5. Review of the policy provided as courtesy. Will provide feedback to Scholastic Standards and Petitions committee to encourage Dept of Retailing to address min requirments for Readmit, Change of Campus and internal change of major, as well. Recommend that all min GPA standards for each type of admission to the program be the same.

#### New business:

M. Miller Discussion about min transfer GPA for math majors. Ask can we have a higher math GPA as a requirement. He noted that math wants to have a min standard for math course GPA average. Discussion regarding how transfer GPAs are calculated in Banner ensued. There are limitations in current forms, modifications to Banner forms are difficult and not being approved by One Carolina Systems Council at this time. Wagner urged that any changes should be uniform and not managed by exception. Miller to continue research on gateway courses and minimum requirements that may need to be applied to all math majors. Ultimately, these would need to be approved by Scholastic Standards and Petitions.

Discussion of Admissions Articles shared in agenda (attached). Committee discussed trends noted in each of the articles.

Meeting adjourned by Smith at 4:52 pm.

#### New business items

#### 1. Bulletin update request

**Issue:** A minimum of 30 transferable semester (45 quarter) hours are required to be considered for transfer admission without requiring a high school transcript and test scores. Currently, military credit earned and presented on a Joint Services Transcript is not considered for admissions purposes under current "30 semester/45 quarter hour" rule for transfer consideration.

**Recommended action:** Allow up to 6 semester hours of ACE-evaluated credit from a Joint Services Transcript to be considered among the 30 hours required for transfer admission. (ACE = American Council on Education)

#### 2. Update ACT Score policy

#### ACT is Superscoring: Affects Admissions criteria, reporting for Summer/Fall 2021 and beyond.

"Beginning with the September 2020 national ACT test date, students who have taken the ACT will have the option to retake individual sections of the ACT test instead of the entire exam.

Students will also have the choice of taking the ACT online, with faster test results, on national test dates, and those who take the test more than once will be provided an ACT "superscore" that calculates their highest possible ACT composite score."

**Issue:** Beginning September 2020, ACT will begin allowing students to retest in specific subject areas rather than have to take the entire test to improve one's "superscore," which is the average of a student's highest subject scores—taken from multiple test administrations—to create a new Composite score. The first freshman class impacted by this change is Fall 2021.

- At present, UofSC only considers highest composite score in a **single sitting**. This practice is aligned with current policy on how SC CHE requires institutions to report ACT scores for profile and state lottery scholarship purposes.
- <u>Many colleges both in and out of the state consider ACT superscores for admission and</u> <u>scholarships.</u> ACT will begin reporting each student's superscore to the student as well as the college to which scores are sent.
- UofSC **does** have the technical and reporting ability to accommodate this score reporting change.
- Acceptance of ACT superscore will have implications for admission, scholarships, downstream reporting.
- SC Assembly has not yet adjusted statue for LIFE and Palmetto Fellows eligiblity. It is expected that they will adopt ACT's new superscore strategy to ensure that students have every opportunity to earn these awards.

**Recommended action:** Effective for the Summer/Fall 2021 freshman term, UofSC UG Admissions – COL will collect and consider ACT superscore for admission and scholarship UofSC consideration. UG Admissions will comply with state statute with regard to requirements to earn LIFE and Palmetto Fellows as well as annual reporting to state and federal agencies.

#### Update on actions UG Admissions has been taking:

- 1. Extended deposit deadline to June 1. Housing app due June 10.
- 2. Transitioning all meetings, activities, tours to virtual events: <u>https://www.sc.edu/about/offices and divisions/undergraduate admissions/connect with us/virtual events.php</u>
- 3. Amending communication plans to afford more opportunities for one-on-one contact with counselor, faculty principles, academic units, etc.
- 4. Messaging SC inquiries about opportunities to apply through April 30. Still can be considered for scholarships if they qualify.
- 5. Allowing a limited number of students to change majors into DMSB.
- 6. We are offering admission to students who have agreed to be on WL. To date, more than 250 have agreed to accept a place in freshman class. All of these are non-residents.
- 7. Upgraded about 2400 non-resident scholarships
- 8. Messaging Fall 2019 non-enrolled freshman applicants who are attending two year colleges in SC about transfer opportunities.

#### AP/IB updates (See ACAP memo from CHE):

- All AP exams will be administered online.
- IB Diploma Programme exams will not be held in any country. However, Diplomas and Certificates will be awarded for the May 2020 session.
  - Coursework, for subjects where students would have been required to sit an exam, will now be externally marked by examiners. Grades for subject level will range 1-7, as they always have.
  - Transcript process will not change
  - Target transcript release is July 5
  - CHE supports institutions' flexibility for assessing students' IB coursework and for awarding credit for IB such that Class of 2020 high school graduates are held harmless.
  - The Commission supports institutions' flexibility for assessing students' IB coursework and for awarding credit for IB such that Class of 2020 high school graduates are held harmless.

#### Bulletin Change request was approved by Faculty Senate.

On June 3, 2020, Chairperson Smith presented the Admissions Committee's approved proposal to allow up to 6 semester hours of ACE-evaluated credit from a Joint Services Transcript to be considered among the 30 hours required for transfer admission. The proposal passed the faculty senate 88-3.

Since this change was approved after the deadline for the fall 2020 bulletin, the approved change will appear in the 2021-2022 bulletin. It will read as follows (key change highlighted in yellow):

An applicant who, having graduated from high school, has attended another regionally accredited postsecondary institution and attempted one or more courses is a transfer student, regardless of credit earned. If fewer than 30 semester hours (45 quarter hours) of college-level work have been attempted, the applicant must meet both transfer and freshman entrance requirements. Applicants with a Joint Services Transcript will receive up to 6 hours of credit toward the required 30 semester hours.

### FACULTY SENATE ADMISSIONS COMMITTEE STATEMENT OF SUPPORT

### Rationale

- COVID-19 has disrupted both in-class and national test administrations of the SAT and ACT. It is estimated that approximately 1 million high school students throughout the U.S. have not taken a college entrance exam compared to same point in time last year.
- To accommodate social distancing guidelines, future testing capacity is limited, which means some students may not be able to take the SAT or ACT at all, as access is largely dependent on number of open test centers, regional population density, and seating capacity.
- At present, SAT or ACT scores are used for admission and scholarship consideration to UofSC, yet it is highly likely that some applicants may not be able to present any scores. Prior to the pandemic, this requirement would prevent a student from being considered for admission.

## **STATEMENT OF SUPPORT – CONT'D**

Faculty Senate Admissions Committee supports and affirms the efforts that Undergraduate Admissions must take to accommodate students without SAT or ACT scores who want to apply as freshmen for the Spring/Summer/Fall 2021 entry term(s). These steps include:

- Provide one-year exception to current SAT/ACT test score requirement. Affects spring/summer/fall 2021 freshman applicants.
- Deploy test-optional admissions pilot that affords students an opportunity to be considered for admission in absence of SAT or ACT scores.
- Encourage students to submit standardized scores from their SAT and/or ACT tests if they have them. Students who are unable to submit scores or do not want to send scores will not be disadvantaged in the review process.
